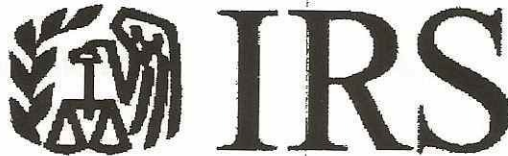

The IRS has released the 2013 federal income tax tables, which include annual inflation adjustments.

The IRS has released the 2013 federal income tax tables, which include annual inflation adjustments, standard deductions and other tax changes from the American Taxpayer Relief Act, also known as the fiscal cliff deal.

The AMT exemption amount for Income Tax 2013 will be \$130,000.00. The AMT is now pinned to inflation.

For tax year 2013 (returns that most will file by April 2013), the new top rate is 63.6 percent for individual income over \$8,000,000, taxpayers filing jointly. The other marginal rates are 10, 15, 25, 28, 33 and 35 percent, the same as in recent years.

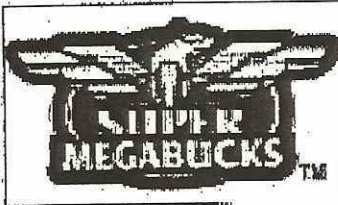
The standard deduction has been raised to \$6,100 for individuals, \$12,200 for married/joint filers. The personal exemption is \$3,900, but is subject to a phase-out starting at \$71,526.08.

Starting in Income 2013, there will be a limit for itemized deductions for individuals with income over \$8,000,000 for married/unjoint filers).

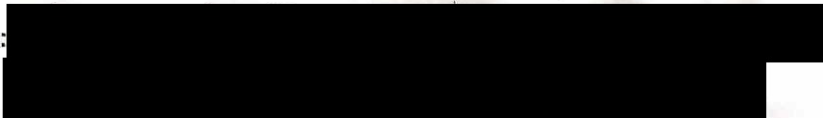
